Depending on country population there are three categories for Country Membership:				
A... < 10 million: € 2,950.-	√			
B... 10-50 million: € 4,950.-				
C... > 50 million: € 6,950.-				
Optional: Discount for low income countries: Low income countries qualify for an optional 25% discount on ICC country Membership. Qualifying countries for a discounted ICC Country Membership fee can be found in the current United Nation's Human Development Index (HDI) list as low and/or medium human development countries OR in the World Bank's list of economies' income as low-income, lower-middle-income economies, and upper-middle-income economies. Making use of the discounted fee reduces the number of votes in the General Assembly, however an upgrading to become a fully paying Country Member is possible at any time and thus securing full voting rights.
